# Seven Business Activities of SMEs

# 1. Agriculture and agricultural products

- 1.1 Plant propagation or seed grading (not required to conduct research and development process)
- 1.2 Manufacture of biological or organic fertilizers
- 1.3 Animal breeding or Animal Husbandry
- 1.4 Crop drying and silo facilities
- 1.5 Tanneries, leather finishing, or fur dressing
- 1.6 Manufacture or preservation of food or food ingredients using modern technology (except drinking water, candy and ice cream)
- 1.7 Manufacture of oil or fat from plants or animals
- 1.8 Manufacture of flour from plants, dextrin or modified starch
- 1.9 Grading, packaging and storage of plants, vegetables, fruits or flowers using modern technology
- 1.10 Manufacture of products from herbs, including soap, shampoo, toothpaste and cosmetics
- 1.11 Manufacture of products made from parawood
- 1.12 Manufacture of products from agricultural by-products or waste
- 1.13 Cold storage or cold storage and transportation
