**SEALED TEMPORARY RESTRAINING ORDER AND ASSET RESTRAINT**

Plaintiff Popilush LLC (“Popilush”) filed an *Ex Parte* Motion for Temporary Restraining Order, Temporary Injunction, and Temporary Asset Restraint (the “Motion”) against the fully interactive, e-commerce stores<sup>1</sup> operating under the seller aliases identified in Schedule A to the Complaint and attached hereto (collectively, “Defendants”) and using at least the domain names identified in Schedule A (the “Defendant Domain Names”) and the online marketplace accounts identified in Schedule A (the “Online Marketplaces”). After reviewing the Motion and the accompanying record, this Court GRANTS Popilush’s Motion in part as follows.

This Court finds, in the absence of adversarial presentation, that it has personal jurisdiction over Defendants because Defendants directly target their business activities toward consumers in the United States, including Illinois. Specifically, Popilush has provided a basis to conclude that Defendants have targeted sales to Illinois residents by setting up and operating e-commerce stores that target United States consumers using one or more seller aliases, offer shipping to the United

States, including Illinois, and have sold products that infringe Popilush’s patent, copyrights, and create a false designation of origin in violation of the Lanham Act (“Popilush’s Intellectual Property”) by way of its sales and marketing to residents of Illinois. In this case, Popilush has presented screenshot evidence that each Defendant e-commerce store is reaching out to do business with Illinois residents by operating one or more commercial, interactive internet stores through which Illinois residents can and do purchase products that infringe Popilush’s Intellectual Property. *See* Docket No. 1 at Exs. 1, 3, which includes screenshot evidence confirming that each Defendant internet store does stand ready, willing, and able to ship its counterfeit goods to customers in Illinois that infringe Popilush’s Intellectual Property. A list of Popilush’s Intellectual Property at issue here is included in the below chart.

This Court also finds that issuing this Order without notice pursuant to Rule 65(b)(1) of the Federal Rules of Civil Procedure is appropriate because Popilush has presented specific facts in the Declaration of Nicholas Ronaldson and Eve DeMartine in support of the Motion and accompanying evidence clearly showing that immediate and irreparable injury, loss, or damage will result to the movant before the adverse party can be heard in opposition. Specifically, in the absence of an *ex parte* Order, Defendants could and likely would move any assets from accounts

in financial institutions under this Court's jurisdiction to off-shore accounts. Accordingly, this Court orders that:

1. Defendants, their officers, agents, servants, employees, attorneys, and all persons acting for, with, by, through, under, or in active concert with them be temporarily enjoined and restrained from:
  - a. using Popilush's Intellectual Property or any reproductions, counterfeit copies, or colorable imitations in any manner in connection with the distribution, marketing, advertising, offering for sale, or sale of any product that is not a genuine Popilush product, not authorized by Popilush to be sold in connection with the Popilush's Intellectual Property, and that infringes Popilush's Intellectual Property;
  - b. passing off, inducing, or enabling others to sell or pass off any product as a genuine Popilush product or any other product produced by Popilush, that is not Popilush's or not produced under the authorization, control, or supervision of Popilush and approved by Popilush for sale in accordance with Popilush's Intellectual Property rights;
  - c. committing any acts calculated to cause consumers to believe that Defendants' products are those sold under the authorization, control, or supervision of Popilush, or are sponsored by, approved by, or otherwise connected with Popilush; and
  - d. manufacturing, shipping, delivering, holding for sale, selling, transferring or otherwise moving, storing, distributing, returning, or otherwise disposing of, in any manner, products or inventory not manufactured by or for Popilush, nor authorized by Popilush to be sold or offered for sale, including any reproductions, counterfeit copies, or colorable imitations, which infringe any of Popilush's Intellectual Property, including any Popilush patent, copyright, or trademark.

2. Defendants shall not transfer or dispose of any money or other of Defendants' assets in any of Defendants' financial accounts.
3. The domain name registries for the Defendant Domain Names, including, but not limited to, VeriSign, Inc., Neustar, Inc., Afiliat Limited, CentralNic, Nominet, and the Public Interest Registry, and the domain name registrars, including, but not limited to, GoDaddy Operating Company LLC, Name.com, PDR LTD. d/b/a/ PublicDomainRegistry.com, and Namecheap Inc., within seven (7) calendar days of receipt of this Order or prior to the expiration of this Order, whichever date shall occur first, shall disable the Defendant Domain Names and make them inactive and untransferable until further order by this Court or until the Order expires, whichever occurs earlier.
4. Upon Popilush's request, those with notice of this Order, including the Third Party Providers as defined in Paragraph 5, shall within seven (7) calendar days after receipt of such notice, disable and cease displaying any advertisements used by or associated with Defendants in connection with the sale of counterfeit and infringing goods using Popilush's Intellectual Property.
5. Any Third Party Providers, including, without limitation, PayPal, Alipay, Alibaba, Ant Financial, Wish.com, and Amazon Pay, shall, within seven (7) calendar days of receipt of this Order:
  - a. locate all accounts and funds connected to Defendants' seller aliases, including, but not limited to, any financial accounts connected to the information listed in Schedule A hereto, any e-mail addresses connected to or affiliated with the Defendants' seller aliases listed in Schedule A and as identified in Exhibits 1 and 3 to the Complaint, and any e-mail addresses provided for Defendants by third parties; and

- b. restrain and enjoin any such accounts or funds from transferring or disposing of any money or other of Defendants' assets until further order by this Court or until the Order expires, whichever occurs earlier.
6. Popilush's Pleading(s), including Docket No. 1 and Exhibits 1-15 thereto, Docket Nos. 9 and 10, Docket No. 11 and Exhibits 1-11 thereto, Docket No. 12 and Exhibits 1-9 thereto, Schedule A to the Pleading Docket Nos. 1 and 5, Docket No. 26 and Exhibits 1-7 thereto, and this Order shall remain sealed until further order by this Court or until the Order expires, whichever occurs earlier.
7. Within seven (7) calendar days of entry of this Order, Popilush shall deposit with the Court \$7,000, either cash or surety bond, as security, which amount has, in the absence of adversarial testing, been deemed adequate for the payment of such damages as any person may be entitled to recover as a result of a wrongful restraint hereunder.
8. Any Defendants that are subject to this Order may appear and move to dissolve or modify the Order as permitted by and in compliance with the Federal Rules of Civil Procedure and the Northern District of Illinois Local Rules. Any third party impacted by this Order may move for appropriate relief.
9. This Temporary Restraining Order without notice is entered at 3:00 P.M. on this 30<sup>th</sup> day of September 2025 and shall remain in effect for fourteen (14) calendar days. Any motion to extend this Order must be filed by October 13, 2025.
