**POPILUSH LLC’S MEMORANDUM OF LAW IN SUPPORT OF ITS EX PARTE  
MOTION TO EXTEND THE TEMPORARY RESTRAINING ORDER**

Under Federal Rule of Civil Procedure 65(b)(2) and the Court’s inherent authority, Plaintiff Popilush LLC seeks to extend the Temporary Restraining Order granted by the Court on September 25, 2025 (Dkt. No. 27) and entered on September 30, 2025 (Dkt. No. 28), by fourteen (14) days until October 28, 2025.

Popilush has been working diligently to ensure compliance with the terms of the order since the Court granted the TRO on September 30, 2025. Ex. A ¶1. Popilush contacted each third-party platform and corresponding domain registrars with demand letters and online portal submissions. *Id.* ¶2. Certain of the third-party platforms responded and complied quickly (e.g., TikTok). *Id.* ¶3. Whereas Popilush is still working with, and waiting to hear back from, other platforms (e.g., Alibaba) as well as domain registrars (e.g., GoDaddy). *Id.* This process has also required additional time as certain defendants are selling exclusively on independent standalone websites—entailing additional steps to try to takedown the infringing content and freeze the assets. *Id.* ¶4.

As of October 13, the third parties are still working on, but have not yet finished, effectuating the terms of the TRO. *Id.* ¶5. Popilush is therefore still working with the third parties to freeze defendants’ financial accounts. *Id.* ¶6.

Under Rule 65(b)(2), a temporary restraining order may be extended for “good cause.” Fed. R. Civ. P. 65(b)(2). Good cause exists here.

**First**, Popilush has been diligent in seeking the third-parties’ compliance with the TRO and asset restraint, yet additional time is needed to fully effectuate its terms. *See* Ex. A ¶7; *see also supra* at 1. **Second**, the threat of harm to Popilush remains high. *Id.* ¶8. As Popilush alleged in the complaint, and explained in its motion for a TRO, it has been “targeted.” *Id.* ¶9; *see also* Compl, Dkt. No. 1 ¶¶50-56 (Sep. 3, 2025); Pl.’s Mem. Law Supp. Ex Parte Mot. Temp. Rest. Order, Dkt No. 10 at 7-9 (Sep. 4, 2025). That fear has been borne out as this case has now been publicly circulated on WeChat. *Id.* ¶10; Ex. B. Worse, at least one Defendant has already discovered this lawsuit—before Popilush could fully freeze their assets. *Id.* ¶11. And other links that were once valid, have now been deactivated before Popilush could seek judicial relief. *Id.* ¶12. Good cause therefore exists for an extension as Popilush will likely continue to suffer harm with no TRO in place.

Courts in this district, recognizing the time required to effectuate the terms of a TRO, the plaintiff’s reliance on third-party cooperation, and the heightened risk of harm until all assets are secured, routinely grant extensions under such circumstances. *Bose Corp. v. Operators of Andwind, et al.*, Case No. 19-cv-07467, Dkt. No. 52 at 2 (N.D. Ill. Feb. 28, 2020) (granting ex parte motion for extension of TRO and explaining that as “this Court and other courts have recognized, proceedings against those who deliberately traffic in counterfeit merchandise are often useless if notice is given to the adverse party.”) (Dirkin, J.); *TV Tokyo Corp. v. The Individuals*,

*Corp., Limited Liab. Companies, Partnerships, And Unincorporated Associations Identified On Schedule A Hereto*, Case No. 25-cv-0444, Dkt. No. 44 (N.D. Ill. Feb. 12, 2025) (“Plaintiff’s motion for extension of ... TRO [43] is granted”) (Kennelly, J.); *Luxottica Group S.p.A. and Oakley, Inc. v. Zheng Ze, et al.*, Case No. 18-cv-06608, Dkt. No. 35 (N.D. Ill. Nov. 6, 2018) (granting ex parte motion for extension of TRO) (Dirkin, J.); *XYZ Corp., et al. v. The Individuals, Corp., Limited Liab. Companies, Partnerships and Unincorporated Associations Identified in Schedule A Hereto*, Case No. 24-cv-01705, Dkt. No. 29 (N.D. Ill. June 4, 2024) (“Plaintiff’s motion for extension of the TRO 26 is granted.”) (Cummings, J.); *see also id.* at Dkt. No. 34 (June 18, 2024) (“The Court has reviewed plaintiff’s motion for second ex parte extension of the TRO 31 and the supplement thereto 33. Within its discretion, plaintiff’s motion for extension 31 is granted in light of the third-party platform’s delay in providing plaintiff with the appropriate information necessary to fully effectuate the TRO.”).

For all these reasons Popilush respectfully requests that the Court grant its motion and extend the TRO for fourteen (14) days until October 28, 2025.

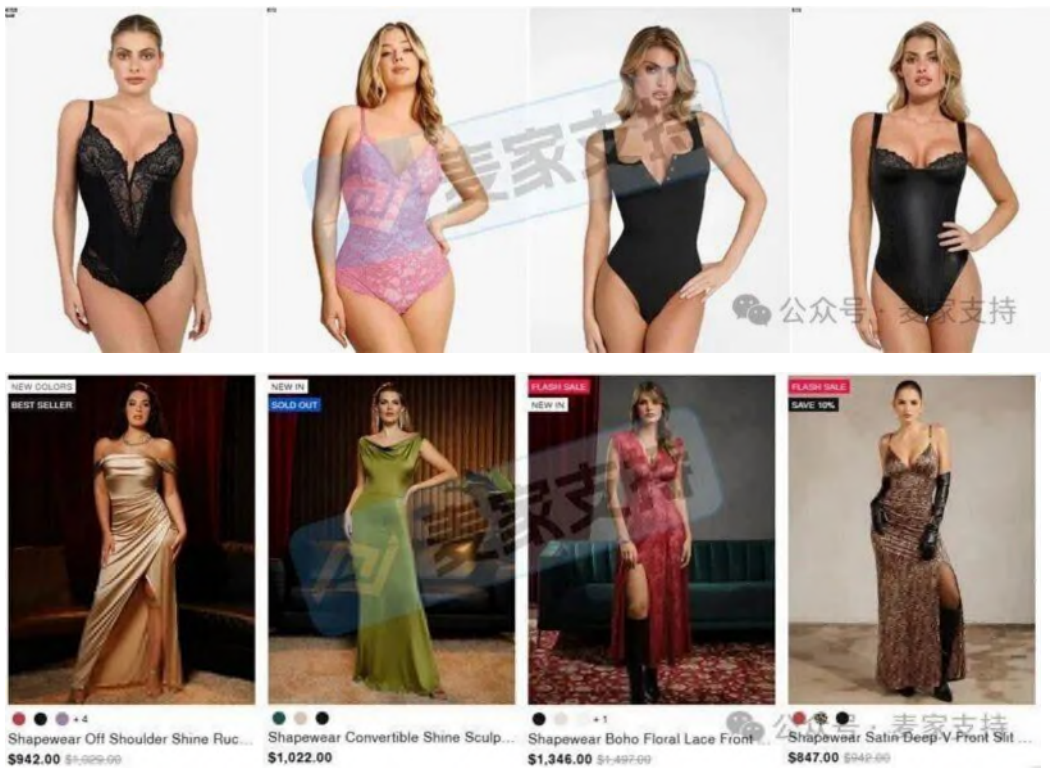

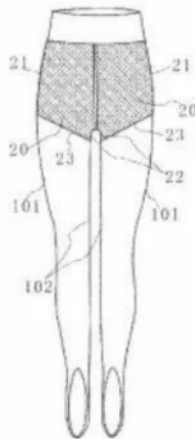

(57) **ABSTRACT**

The present utility model relates to the technical field of body-shaping clothes, and in particular to thigh-constricting and hip-lifting body-shaping pants. The thigh-constricting and hip-lifting body-shaping pants include a pants body, wherein the pants body has a second shaping portion on a back side of the pants body and a first shaping portion on a front side of the pants body; the first shaping portion is arranged corresponding to upper thighs and a pubis region and has two inner side edges extending to inner thighs and two outer side edges extending to outer thighs; and the second shaping portion is arranged corresponding to positions below hips, and both ends of the second shaping portion and the corresponding outer side edges of the first shaping portion are connected at the outer thighs, respectively.

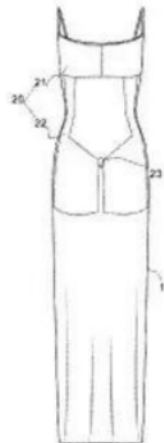

(57) **ABSTRACT**

A dress with a body-shaping function comprises: an outer dress composed of a dress body and straps connected to a collar of the dress body; and a body-shaper lining located inside the dress body and completely covered by the dress body, wherein a top end of the body-shaper lining is sewn or bonded on the dress body along the collar of the dress body, and the body-shaper lining is of a jumpsuit structure and has at least one body-shaping area. The joint of the body-shaper lining on the outer dress can be hidden, and no obvious bonding trace will be seen from the appearance of the outer dress; and the dress body can be held by means of the tension of the body-shaper lining next to the skin and the suspension effect of the straps.

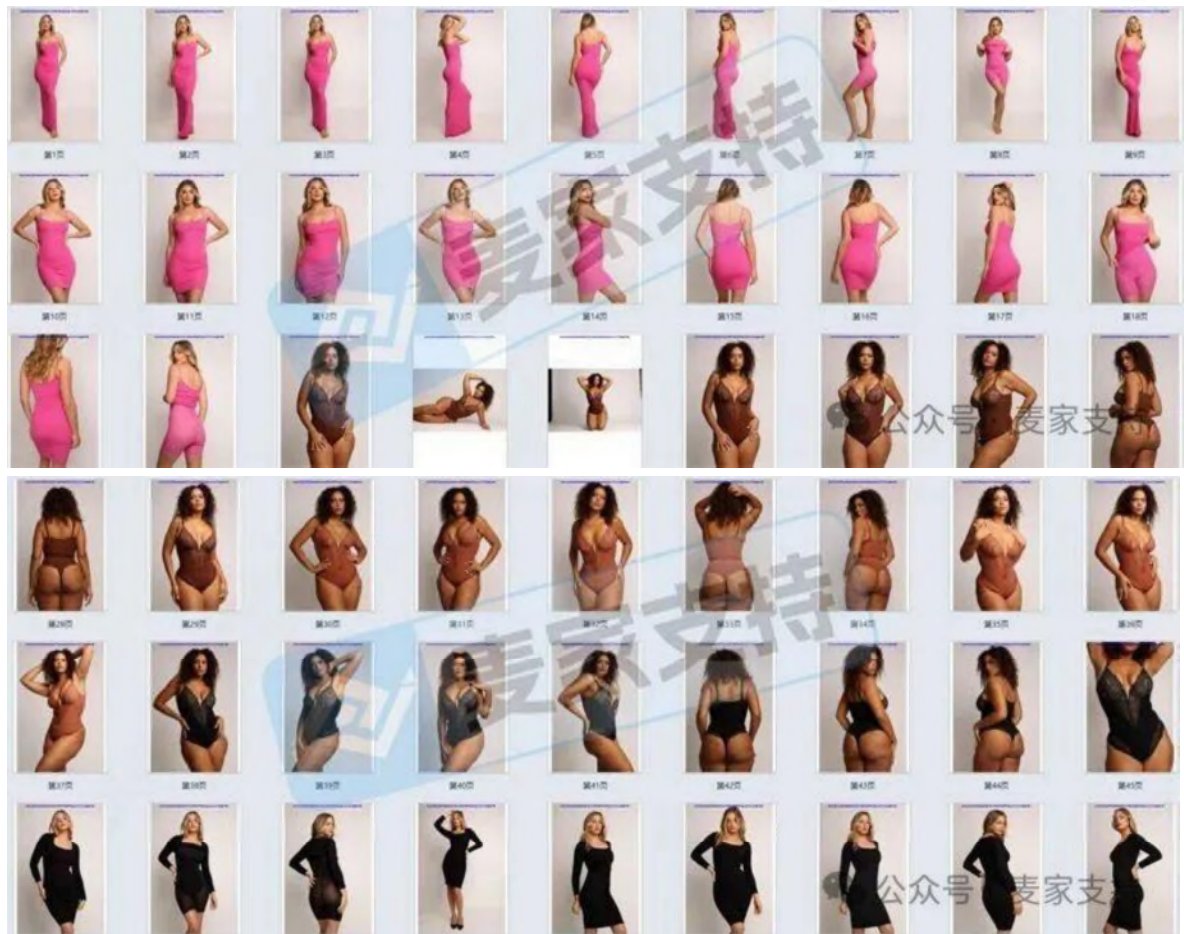
