### Highlights of the month

#### [\\*EUROPEAN PARLIAMENT PROPOSES AMENDMENTS TO DRAFT REGULATIONS ON CONSUMER PRODUCT SAFETY AND MARKET SURVEILLANCE](#)

We previously reported in our Legal Update dated 25 February 2013 that the Commission had published a new package of measures to improve product safety in the EU including a draft Regulation on the market surveillance of products (2013/0048(COD)) and a draft Regulation on consumer products safety (2013/0049(COD)). The European Parliament has now published two draft reports proposing its own amendments to the Commission proposals. The two proposals introduce significant amendments including reinforced penalties for violations of the proposed requirements, extended powers for the Commission, or the creation of a new “CE+” marking, and more generally introduce a strong emphasis on the use of the Precautionary Principle in the two legal frameworks. Importantly, the Parliament amendments also blur the line between dangerous and non-compliant products, a cause for concern which could have a significant impact on all industry stakeholders.

#### [\\*STUDY MAKES RECOMMENDATIONS ON SCOPE OF FUTURE BELGIAN NATIONAL REGISTER FOR NANOMATERIALS](#)

A study conducted by consultant BiPRO GmbH for the Belgian Federal Public Service Health, Food Chain Safety and Environment makes a series of recommendations in preparation for the upcoming Belgian measure establishing a mandatory national register for nanomaterials. While the early draft of the measure (which has yet to be published) is understood to be largely based on the French framework for nano declarations, the report recommends key adjustments including (1) an exemption for selected pigments and fillers in preparations and articles, (2) an exemption for retailers and micro or small wholesalers, (3) a general exemption based on scientific evidence including non-testing methods, and (4) a progressive entry into force of the declaration requirement first for substances, then preparations, and finally articles.

#### [\\*EFSA POSTPONES COMPLETION OF BISPHENOL A REEVALUATION TO 2014](#)

In February 2012, EFSA’s CEF Panel decided to fully re-evaluate the risks associated with exposure to BPA. The results of the evaluation were initially expected by May 2013, but EFSA has just announced in a press release dated 28 June 2013 that a two-stage public consultation on its draft exposure assessment is to take place before finalizing of its scientific opinion. The first stage of the consultation will be an online public consultation from mid-July to mid-September 2013. The second stage of the consultation will be a public consultation on the human health aspects of EFSA’s risk assessment that will take place in early 2014. As a result, the final reevaluation is not expected to be published before mid-2014.

#### \*PUBLIC CONSULTATION ON REACH ANNEXES ON NANOMATERIALS

The EU Commission has launched a public consultation on the technical provisions for nanomaterials that are set-out in REACH Annexes as a response to the conclusions of the Second Regulatory Review on Nanomaterials and the General Review of REACH. An impact assessment of various regulatory options, including amendments of REACH Annexes will be conducted and it is anticipated that the report, together with a Commission proposal for amendment of REACH (if appropriate), will be released by December 2013.

#### \* EU COMMISSION TENDER FOR AN IMPACT ASSESSMENT ON AN EU-NANO REGISTRY

A new call for tender has been published by the EU Commission in order to assist them determine whether, in addition to existing REACH and CLP information requirements, including those considered for the planned revision of REACH Annexes (see above), there should be new measures to increase transparency and ensure regulatory oversight on nanomaterials (“nanomaterials registry”). Tasks will include the gathering of relevant data needed for this impact assessment, in particular costs and administrative burden of possible registration obligations to companies, possible effects on their competitiveness and possible effects of discouraging innovation in Europe, along with potential benefits of the created information for consumers and policy makers, compared to existing information sources. The deadline for tender applications has been set on 19 August 2013.
